RESOLUTION OF THE BOARD OF SUPERVISORS OF ORANGE COUNTY, CALIFORNIA

WHEREAS, on July 14, 2020, the Board of Supervisors of Orange County, California adopted Resolution Number 20-092, revising rates for Agricultural Services and Quarantine Certification; and Produce Documentation and Certification.

WHEREAS, updating fees for mandated services by the Agricultural Commissioner- Sealer of Weights and Measures will ensure continued protection of public safety, environmental health, and business competitiveness while reducing Net County Cost.

NOW, THEREFORE, BE IT RESOLVED that this Board does hereby rescind Resolution Number 20-092 concerning Agricultural Services and Quarantine Certification and approves the following revised rates for Agricultural Services, Quarantine Certification, and Produce Standardization Certification.

BE IT FURTHER RESOLVED that this Board does hereby approve the implementation of the attached fee schedule's first year increase on July 1, 2024, second year increase on July 1, 2025 and third year increase on July 1, 2026.

BE IT FURTHER RESOLVED that this Board does hereby find that, in accordance with Section 21080(b)(8) of the California Public Resources Code, the proposed rates are for the purpose of meeting operating expenses, and therefore, are exempt from the provisions of the California Environmental Quality Act pursuant to Section 15273(a).

BE IT FURTHER RESOLVED that said fees do not exceed the reasonable cost of providing the services for which they are levied and are not levied for general revenue purposes.
