First year increase on July 1, 2015, Second year increase on January 1, 2016 and Third year increase on January 1, 2017.

On and after July 1, 2018, the fees shall be adjusted annually by the California Consumer Price Index to an amount that is 73% of the full program cost. On July 1, 2020, and each three years thereafter, the Auditor-Controller shall perform a cost recovery analysis for the program and OC Public Works shall adjust the fee schedules based upon the Auditor-Controller's determination of actual costs such that only 73% of the cost is recovered.
