



PEST CONTROL BUSINESS 2020 ANNUAL REGISTRATION

Dear Pest Control Operator,

This letter is to inform you that the registration allowing your Pest Control Business to conduct operations in Orange County will expire on December 31, 2019. You **must register by January 1, 2020** in order to continue your business in Orange County during the 2020 calendar year. *It is a violation to perform work in Orange County without first registering with the County Agricultural Commissioner.*

Appointment times are available from 8:30 am - 11:15 am and 1:15 pm - 3:30 pm, Monday - Thursday.

	2. A copy of your company's 2020 State Pest Control Operator Business License.
	3. A copy of your 2020 Qualified Applicator License card.
	4. Completed Application for Pest Control Equipment Registration (enclosed).
	5. \$89.00 registration fee (Check or money order) (Payable to: Orange County Treasurer)
	New fee effective as of July 1, 2015

If you require a **Restricted Materials Permit**, do the following:

- > Call (714) 955-0100 at least 24 hours to make an appointment before you come in to register.
- > Specify any changes to be made to an existing Restricted Materials Permit.
- ➤ If you are headquartered outside of Orange County, bring in a copy of your 2020 Restricted Materials Permit issued by your home county.
- > Be prepared to disclose mitigating measures and alternatives to using restricted materials used by your business.
- ➤ The Restricted Material Permit will not be issued by mail.
- > Completed Pest Control Business County Registration form, along with all names and QAL/QAC numbers that work for your company (on the backside of the registration form).
- A copy of your Pest Control Business License and Qualified Applicator License issued by the California Department of Pesticide Regulation and valid for the year 2020.
- Completed Application for Pest Control Equipment Registration (enclosed), be sure to put your company name at the top. A copy of one completed for another county is acceptable.
- > \$89.00 registration fee (check or money order) payable to: Orange County Treasurer

SUBJECT: Notice of Pesticide Applications

CCR Section 6618 requires certain notifications to be provided to the "operator" of the property where pesticides are being applied, as well as to persons whom the operator has reason to believe may enter the property during and after the application period. Anyone applying pesticides is required to notify the operator of the property (i.e. the HOA) the following three items PRIOR to conducting any pesticide application:

- 1. The date(s) of the scheduled application of pesticides to the property
- 2. The identity of the pesticide by brand or common chemical name
- 3. The precautions printed on the pesticide label or included in laws and regulations to protect persons during the application.

6618. Notice of Applications.

- (b) This subsection applies to the use of any pesticide for purposes other than the commercial or research production of an agricultural plant commodity. Notifications required by this subsection must be given orally or in writing and be completed prior to the use of any pesticide and in ample time for all subsequent notifications to be made and for all persons notified to take appropriate action. This time will differ depending on the circumstances of each notification.
- (1) Each person performing pest control shall assure that the operator of the property receives notice of the scheduled application. The notice must be in a manner the person can understand and include:
- (A) The date of the scheduled application;
- (B) The identity of the pesticide (including spray adjuvants, if applicable) by brand or common chemical name; and
- (C) Any other precautions printed on the pesticide product labeling or included in applicable laws or regulations related to the protection of employees or other persons during the application.
- (2) The operator of the property shall assure that notice is given to all persons who are on the property to be treated, or who may enter during the application or the period of time that any restrictions on entry are in effect, except for the persons who made or supervised the application for which the notice is intended. The notice must be in a manner the person can understand and include:
- (A) The date of the scheduled application;

- (B) The identity of the pesticide (including spray adjuvants, if applicable) by brand or common chemical name; and
- (C) Precautions to be observed as printed on the pesticide product labeling or included in applicable laws or regulations related to the entry of the treated area.
- (3) Compliance by licensed Structural Pest Control Operators with the notice requirements of section 8538 of the Business and Professions Code meets the requirements of this subsection.
- (4) Compliance by public agencies with the notice or barrier requirements of section 12978 of the Food and Agricultural Code meets the notice requirements of this subsection.

TO: 2020 ORANGE COUNTY RESTRICTED MATERIALS PERMIT HOLDERS

Title 3, CCR section 6426 requires the permit applicant (grower) and his/her pest control adviser to consider **alternatives** to the use of a restricted material before applying for a permit. While this specific requirement is directed at agricultural use, the general requirement to consider alternatives applies to all permits. To determine compliance with this requirement, we are asking you, the permit applicant, to identify the alternatives that you considered. **If you acknowledge** that you did not consider alternatives, we will refuse the permit at this time and direct you to comply with section 6426.

Title 3, CCR section 6426 Alternatives and Mitigation Measures.

(a) Each licensed agricultural pest control adviser and grower, when determining if and when to use a pesticide that requires a permit, shall consider, and if feasible, adopt any reasonable, effective and practical mitigation measure or use any feasible alternative which would substantially lessen any significant adverse impact on the environment. NOTE: Authority cited: Sections 11456, 14005 and 14102, Food and Agricultural Code. Reference: Sections 11501 and 14006, Food and Agricultural Code.

EXAMPLES OF MITIGATION (Reducing the significance of adverse effects of Restricted Materials)

USE LESS PESTICIDES

Use pesticides in "spot" treatments, where and when they are needed.

Use Proper timing; regular monthly or bi-monthly spraying wastes pesticides.

In addition, during many of these treatments, pests may not be present or present in numbers so small that they are causing no problem. For some pests, treatments must be times to coincide with a period in their lives when they are most vulnerable.

Use Integrated Pest Management (IPM)

Determining the number of pests that can be tolerated without causing unacceptable damage or annoyance. Pests are treated only when they reach that level.

Use Less Toxic Pesticides

Biochemical pesticides (Round Up instead of Trimec, etc.)

EXAMPLES OF ALTERNATIVES (Alternatives to Restricted Materials)

Consider nonchemical alternatives

Beneficial predators

Learn to recognize common predators such as ladybugs, syrphid flies, and lacewings. If you see them in abundance, you may want to postpone any treatments to see if these natural enemies will solve problems for you.

Microscopic Pathogens Consider Manual Alternatives

Parasitoids

Spading and **hoeing** to cut up weeds.

Setting **traps** to control rats, mice, voles, moles, gophers, and some insects. Mulching to reduce weed growth

Consider the Use of Physical Controls and Exclusion

Copper strips to keep slugs and snails away from plants.

Caulk to plug pest entry holes in buildings, or

Sticky barriers that keep ants out of areas.

Fabric row covers exclude insects and birds.

Weed control fabric suppresses weeds.

Consider Cultural Controls

Choose proper plants for the climate.

Choose plants for pest and disease resistance.
